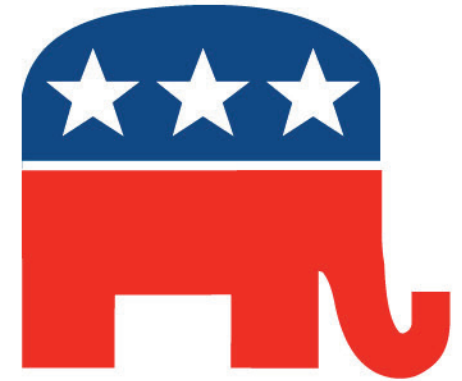
The Nevada Republican Men’s Club has been bringing conservatives together in Las Vegas since 1981 to showcase Republican principles and American exceptionalism.
